*Referring member and referred member must be 18 years of age or older to qualify for this program. Referring member must be an account holder in good standing and not have caused FSFCU any losses. Persons being referred may not be an existing FSFCU member, joint account holder, borrower, co-borrower or co-signer, nor had an account with FSFCU within the last 12 months. FSFCU employees and volunteers are not eligible to participate in this program.

Referred member can only be referred by one FSFCU member. Referred member must have a completed Refer A Friend form when applying for membership in order to qualify. All new membership accounts are subject to standard account eligibility and opening procedures. This offer may not be combined with any other offer at the time of account opening.

Ninety (90) days after the referred member has opened a checking account, Fort Sill Federal Credit Union will electronically deposit \$25 into the referring member's savings account and \$25 into the referred member's savings account. There is no limit to the number of eligible referrals a member can submit and no limit to the number of rewards a member can receive. Referral rewards paid to the referring and referred member may be taxable and are the members' sole responsibility. By participating in this referral program, members acknowledge and understand that both the referring member and referred member may learn that the other has an account with FSFCU.

FSFCU reserves the right to disqualify any referral that FSFCU reasonably believes was not sent in good faith. FSFCU also reserves the right to change or cancel this offer at any time without notice. Other restrictions may apply. Offer begins May 1, 2018 and expires June 30, 2018. Referred member's checking account must be opened by June 30, 2018.

This drawing is being administered and operated by Fort Sill Federal Credit Union, P.O. Box 1527, Lawton, OK 73502-1527.

ELIGIBILITY: The drawing is open to the Referring Member. Referring Member must be 18 years of age or older; an account holder in good standing; and has not caused FSFCU any losses. FSFCU employees and volunteers are not eligible to participate in this drawing.

HOW TO ENTER: When a new checking account is opened by a person (age 18 or older) who was referred to FSFCU by an existing FSFCU member, the Referring Member will automatically be entered into the drawing. The Referring Member will be entered into the drawing for every opened checking account referral received. There is no limit to the number of entries per a Referring Member.

TIME PERIOD FOR ENTRIES: Entries for the drawing may be made beginning May 1, 2018 through June 30, 2018.

DATE OF DRAWING: The drawing will be July 15, 2018.

SELECTION OF WINNER: On July 15, 2018, one (1) winner will be determined by a random drawing from all eligible entries that are received in accordance with these terms and conditions.
